## Membership agreement

- I understand that throughout the season, the C.S.A. Manager will communicate with all shareholders via e-mail. Her e-mail address is [Lindy@littlefox.farm](mailto:Lindy@littlefox.farm). Members may also reach her directly by phone at (954)-918-8519.
- I have read and understand the details of my purchased share, including the cost, the duration of the season, and the size of the weekly share. I recognize that all information regarding this matter can be found, online, at: LittleFox.Farm under the "CSA" tab, near the top of the page.
- I acknowledge that I will pick up my weekly share at one of the designated pick-up locations. In the event that I am unable to pick up my weekly share, I agree to notify the C.S.A. Manager as soon as possible to inform her of the change. I also recognize that I can have someone else pick up my share as long as I notify the C.S.A. manager ahead of time.
- I understand that if I do not make my weekly pickup, my share will be donated to Second Helpings Atlanta, Inc. and is non refundable.
- I understand that to pick up my share, I must be at the location specified on my application, within the scheduled time frame:

- I understand that my C.S.A. membership fee is completely non refundable.
- I understand that I am to pay the total of my C.S.A. membership payment all at once, and until that point I am not a confirmed member.
- I acknowledge that to pay my membership fees I must send the completed membership agreement form, the completed membership application, and a check of my purchase total, by mail to the farm address. I understand that checks can be made out to: Little Fox Farm LLC.
- I understand that there is a risk of crop failure and that as a result the weekly C.SA. share may not always contain such a wide variety if crop failure occurs.
- I understand that Little Fox Farm is a C.N.G. certified farm and therefore uses no synthetic fertilizers or pesticides in their crop production. I understand this causes a slight risk for some produce to be effected by wildlife and environmental factors but as a C.S.A. Program Member, I am given a higher priority in terms of crop distribution. In the event of crop failure, Little Fox Farm will provide vegetables/fruit from another local farm to supplement. In this case we will only supplement with items from farms that meet the same growing standards as Little Fox Farm.
